**Legislative Bill#: HCR2004: clean elections repeal;
education funding**

LWVAZ position on this bill: **OPPOSE**

**HCR 2004 (Rep. Vince Leach), which would put on the
ballot a referendum to defund Citizens Clean Elections.**

LWVAZ was instrumental in the creation and then passage of an Initiative to create the Citizens Clean Elections Commission; and has supported it's existence ever since. Now it is time for LWVAZ to stand up and let our Legislators know that we continue that support. Clean Elections not only takes a lot of money out of political races and thus encourage candidates to speak and listen to their constituents – and has allowed a broader more diverse group of candidates run for office – but it also is the leading entity in AZ on voter education efforts, which provides such for often very cash strapped cities, towns, counties, and the Native American community, helping to people understand how to register, how to vote and how to be an informed voter, which is what LWV has always encouraged and stood for. We recognize that this bill would provide more funding to public schools, which LWVAZ has also supported – based on the AZ Constitution which mandates such – but LWVAZ believes that there are many other mechanisms available to the AZ Legislature to provide such increased funding that should not be in conflict with the goals of the Citizens Clean Elections Commission.

Key points to use when making your comments known:

1. Important that Arizona keep a system that has allowed countless candidates to run without having to raise money from lobbyists and special interest groups
2. A leading entity in providing voter education efforts statewide
3. This is not an appropriate trade-off for more funding for education. Adequate and increased education funding

should not be in conflict with the goals of the Citizens Clean Election Act.
